<u>DISCUSSION</u>: BENLIC acquired the property of 33 Donna, Depew via Erie County's In Rem auction 163, by using its "super bid" authority to bid the total amount of back taxes owed on the property. Conveyance of title to BENLIC occurred on October 29, 2015. BENLIC endeavors to sell the property to a responsible moderate-income homebuyer in accordance with a grant agreement between BENLIC and the New York State Office of the Attorney General. 33 Donna is in poor condition; the Village has cited it as an unsafe structure and Erie County Department of Environment and Planning Senior Housing Inspector Del Costello believes the structure should be demolished. BENLIC possess funds from the Attorney General to demolish properties throughout the County. Additionally, the parcel of 33 Donna is of considerable size and is located in a desirable and cohesive neighborhood – new construction, particularly of a modular or panelized residential structure, could be pursued to meet BENLIC's grant deliverable of selling homes to moderate income buyers in accordance with its grant from the New York State Attorney General's Office.
