# **DISCUSSION:**

BENLIC acquired the property of 69 Ross, Buffalo via donation from Wells Fargo Bank NA. Conveyance of title to BENLIC occurred on September 23, 2015. BENLIC endeavors to rehabilitate and resell the property to a responsible moderate-income homebuyer in accordance with a grant agreement between BENLIC and the New York State Office of the Attorney General. An average development budget for a City of Buffalo-located residential rehabilitation property as part of the 2<sup>nd</sup> Round of Attorney General funding is \$90,000. BENLIC has performed exterior improvements to the property including new roof, gutters, soffit and fascia, and windows installation. With priority exterior concerns addressed, a work scope for interior items was developed by engagement with ecoLOGIC Studio, an engineering/ architectural/ design company; the work scope includes: insulation, wall board and ceiling repair, flooring, painting, and replacement of mechanicals, installation of smoke detectors and receptacles, and more.
