# **DISCUSSION**:

BENLIC acquired the property of 365 Northumberland, Buffalo via preemptive bid at City of Buffalo's In Rem Foreclosure auction in 2015. BENLIC endeavors to rehabilitate and resell the property to a responsible moderate-income homebuyer in accordance with a grant agreement between BENLIC and the New York State Office of the Attorney General. Some improvements have been made to the property including installation of new roof and gutters and asbestos abatement. ecoLOGIC studios architects were engaged to complete construction notes and drawings for the remaining work on the property. The bid for Complete Project was put out on September 13, 2016. A pre-bid walk-thru was held on September 20, 2016.

- RESOLVED, that BENLIC Board of Directors authorizes BENLIC to execute an agreement for construction services to the property of 365 Northumberland contingent on a successfully negotiated reduced cost figure for the benefit of BENLIC and in accordance of a grant between BENLIC and grant project funder, the New York State Attorney General's Office; and be it further
