# **DISCUSSION**:

BENLIC acquired the structure at 652 Lisbon at the City of Buffalo In Rem auction as part of the corporation's share of bid assignment properties. The property requires minimal rehabilitation. BENLIC endeavors to bid out the necessary repairs, and sell the property a responsible moderate-income homebuyer in accordance with a grant agreement between BENLIC and the New York State Office of the Attorney General.

Building inspector Corey Baskerville has since completed a comprehensive scope of work detailing a full rehabilitation project, from which staff submitted the project for bid on May, 5 2017. A pre-bid walk thru was held on May 9, with a submission deadline of May 17. Work includes new exterior and interior doors, service furnaces, replace hot water tanks, new electrical service, and plumbing testing. Both units kitchens repaired including flooring, drywall repair and fixtures repair; the entire dwelling unit will be painted. BENLIC obtained lead paint report and work scope also directs interim controls be taken to make the home lead safe.
