DISCUSSION:

The Buffalo Erie Niagara Land Improvement Corporation (BENLIC) acquired the property of 33 Donna Court, Village of Depew via Erie County's In Rem auction 163. The original structure at 33 Donna was in extremely distressed condition, and on March 24, 2016 the Corporation approved demolition of the structure. BENLIC utilized funds from the County-wide demolition fund provided by the NYS Attorney General. BENLIC contracted IQ Modular to construct a new single-family modular residence in May of 2016 with funding from the NYS Attorney General. The project was completed the following year and listed for sale in September 2017 at price of \$149,900.



BENLIC staff has reviewed the offers including respective Property Purchase Applications. The purpose of the proposed disposition is congruent with BENLIC's mission to return property to productive use.
