DISCUSSION:

BENLIC is currently undertaking ten (10) major rehab projects – seven funded by LISC through the NYS AG bank settlement funds, and another three projects, also funded by LISC, in partnership with National Communities Stabilization Trust (NCST). Greater funding for these projects is leveraged by BENLIC matching funds at a ratio of 70% LISC/30% BENLIC.

Since start of work in mid-Spring of 2018, some projects have necessitated need for formal change orders because of a) unanticipated or unknown work, b) work required by local municipal authorities, c) work items not put in initial scope for original bids/work items deemed necessary after bid-related work items were completed.

Attached to this resolution and made a part hereof is a schedule of **101 Balbach**, **Cheektowaga**, one of BENLIC's 2018 Rehab Grant Projects, the schedule displays change orders proposed in detail for this project.
