SUBJECT: Resolution #2018-56 Approval to Bid Properties at County of Erie Tax Foreclosure

Auction – City of Buffalo Property

DATE: September 20, 2018

DISCUSSION:

The City of Buffalo Office of Strategic Planning (OSP) identified 34 absentee-owned properties slated to be auctioned in Erie County's In Rem sale 2018. OSP used data from the City's Housing Opportunity Strategy to analyze property and block conditions. The properties and blocks were rated from 1 (highest) to 5 (lowest). The list of 34 identified properties comprised of properties rated *at* or *below* the various block's average, with a strategy to consider acquisitions and improvement of properties that were adversely affecting the block.

BENLIC Staff subsequently worked to obtain information regarding properties' vacancy status. Four (4) properties of the original 34 were found to be vacant. BENLIC staff identified an additional seven (7) vacant properties as appropriate candidates considering their rating, vacancy status, and physical condition. OSP provided a Structure Acquisition Applications for the eleven (11) properties in accordance with BENLIC Rules and Procedures. The below properties are of interest to the Corporation.
