## **DISCUSSION**:

The Buffalo Erie Niagara Land Improvement Corporation (BENLIC) acquired the property of 100 Lordan Drive, Town of Cheektowaga via the 2018 Erie County In-Rem. BENLIC performed extensive preservation work before marketing the property as a Note and Mortgage opportunity. BENLIC listed the property for sale in March 2019 at a price of \$70,000.00 This property was marketed in-house by BENLIC staff.



The property is being sold under BENLIC's "Note & Mortgage" program. Therefore, there are no income limit requirements for potential buyers. The purpose of the proposed disposition is congruent with BENLIC's mission to return the property to productive use.

- RESOLVED, that in the event BENLIC and Nicholas Giambra are unable to complete the sale of the property, the BENLIC Board of Directors authorizes the disposition of the property of 100 Lordan Drive, Town of Cheektowaga NY (SBL# 125.09-11-31) in the amount of \$80,100.00, by an Agreement of Sale of Real Property with second priority to offeror RJM Homes LLC., and in so doing follows the proper procedure for disposal of real property by negotiation as described in the Property Disposition Guidelines of the Corporation; and be it further,
