## **DISCUSSION:**

BENLIC acquired 66 Burch Avenue, West Seneca NY via 2016 Erie County In-Rem tax foreclosure auction. The property was a viable candidate for BENLIC rehabilitation as a single-family home on the West Seneca/Buffalo border. The BENLIC Board of Directors previously approved a bid for complete rehab of the home via BENLIC Resolution #2018-21. Since then, significant improvements and stabilization work have been completed. BENLIC has chosen to re-bid remaining work-items to ensure they are completed in an efficient and timely manner.

The bid package was prepared by BENLIC Building Inspector, major repair items include:

- New Kitchen
- New Floor Finishes
- New Bathroom
- Exterior Repairs

The bid was released on March 26<sup>th</sup>, 2019, with a submission deadline of April 15th, 2019.
