DISCUSSION:

BENLIC acquired 34 Wanakah Heights, Village of Hamburg as a donation by the National Community Stabilization Trust (NCST). The NCST is a non-profit organization that works to achieve similar goals of eliminating property vacancy and abandonment throughout the United States. By settling REO Foreclosures, the NCST is able to donate, or sell property to community housing organizations.

Properties acquired through Mr. Cooper (aka Nationstar) are eligible to receive up to \$20,000.00 in rehabspecific grant funds through the *NCST Mr. Cooper Program*; properties under this program are not income restricted. BENLIC was able to secure the \$20,000.00 of these grant funds to assist in stabilization efforts and has used this opportunity to shape an appropriate bid package for a property needing minor repairs.

The bid package was prepared by BENLIC Building Inspector, the scope of work was mostly minor repairs with a few of the major items that included:

- Heating, Electric, and Plumbing
- Roof Repairs

The bid was released on January 22nd, 2019, with a submission deadline of February 15, 2019.
