### **DISCUSSION:**

The Buffalo Erie Niagara Land Improvement Corporation (BENLIC) acquired the property of 93 Lake Street, Village of Angola via the 2017 Erie County In-Rem Foreclosure Auction. The Corporation disposed the property via Resolution #2018-9 in March 2018 to Emmett and Kelley Lonergan for \$3,500.00, the property with a Note and Mortgage Agreement for \$24,067.00 (the "Agreement"). This property has received two 6-month extensions. One granted in July 2019 via Resolution #2019-36 and another granted in November 2019 via resolution #2019-58.

BENLIC Staff has been in communication with the purchasers who report additional time will be needed to satisfy the required rehabilitation work under the Agreement. BENLIC Staff believes this request to be reasonable due to the original condition of the home and significant work performed to-date by the purchasers as well as the construction slowdowns resulting from the COVID-19 pandemic.

RESOLVED that the BENLIC Board of Directors authorizes the extension of the term of the Agreement by six (6) months from June 20, 2020 to December 20, 2020; and be it further,

RESOLVED, that BENLIC authorizes Jocelyn Gordon, as Executive Director, along with BENLIC legal counsel to take all necessary actions required to execute and record a modification to the Agreement with Emmett and Kelly Lonergan.
