- 2. Approval of March 2020 Minutes with Real Estate Committee Minutes:

 The minutes of the March 19th, 2020 Board of Directors Meeting were presented and reviewed. A motion to approve was made by Michael Siragusa, seconded by Scott Bylewski and unanimously carried as approved.
- 3. <u>Treasurer's Report</u>: Chairman Mehaffy presented the March 2020 Treasurer's Report as of March 31st, 2020 with a balance of \$3,254,461.29, this includes \$1,500,000.00 in Treasury Bills the Corporation filed for in late December of 2019. A motion was made to approve by William Reece, seconded by Michael Siragusa, and unanimously carried as approved.

4. Bid Approval

Resolution #2020-13- 117 Dupont Avenue, Tonawanda – Asbestos Abatement

BENLIC acquired 117 Dupont Avenue at the Erie County In-Rem Auction in 2019. BENLIC has invested \$4,050.00 in funds to stabilize and receive necessary asbestos testing and survey of the property. The plan is to bid out the remaining necessary repairs – around \$120,000.00 remain in repairs and sell the property to a responsible homebuyer. An estimated resale is around \$130,000.00. After obtaining an asbestos pre-renovation survey of the property that revealed the home contained friable asbestos materials throughout. The bid for asbestos abatement was released on March 9th, 2020, with a submission deadline of March 31st, 2020. BENLIC received four (4) bids: Regional Environmental Demolition, Inc. (\$14,800.00), Priority Abatement and Remediation (\$21,300.00), Lee's Environmental Services, Inc. (NYS MBE - \$24,790.00), and SEG Construction (NYS WBE - \$28,000.00). A motion to approve Regional Environmental Services, Inc for \$14,800.00 was made by Timothy Ball, seconded by William Reece, and unanimously carried out as approved.

A motion to adjourn the meeting was made by Timothy Ball, and seconded by William Reece, and unanimously carried as adjourned.
