# **DISCUSSION:**

The Buffalo Erie Niagara Land Improvement Corporation (BENLIC) acquired the property of 35 Hedwig Avenue, Town of Cheektowaga via the 2019 Erie County In-Rem Auction. BENLIC invested funds towards securing the property and removing disturbed asbestos materials in the basement. The property was listed in December of 2020 for a sale price of \$39,900.00



The property is being sold under BENLIC's "Vacant to Value" program. Therefore, there are no income limit requirements for potential buyers. The purpose of the proposed disposition is congruent with BENLIC's mission to return property to productive use.

- RESOLVED, that in the event that BENLIC and Buffalo Dreams Realty LLC. are unable to complete the sale of the property, the BENLIC Board of Directors authorizes the disposition of the property of 35 Hedwig Avenue, Town of Cheektowaga, NY (SBL# 102.53-3-27) in the amount of \$71,000.00 by an Agreement of Sale of Real Property second priority to offeror Mohammed Abdul, without further Board approval, and in doing so follows the proper procedure for disposal of real property negotiation as described in the Property Disposition Guidelines of the Corporation; and be it further,
- RESOLVED that the disposition of the property include a Note and Mortgage held by BENLIC to ensure the development of the property in an amount equal to 82% of the work cost estimate prepared by BENLIC, \$50,000.00; and be it further,
