## 2. Approval of October 2021 Minutes:

## 4. <u>Dispositions</u>

Resolution #2021-35 Disposition of 74 Halstead, Village of Sloan

BENLIC acquired the property of 74 Halstead Avenue, Village of Sloan and used funding from its general fund to rehabilitate the home. BENLIC listed the property for sale in September 2021 for \$159,900.

BENLIC received an offer from Shahadath Ahmed for \$160,000.

The property is being sold "as-is". No grant funding has been utilized for the redevelopment of this property. Therefore, there are no income limit requirements for potential buyers or a Development Enforcement Lien. The purpose of the proposed disposition is congruent with BENLIC's mission to return the property to productive use.

A motion to approve the disposition of 74 Halstead was made by Amanda Mays, seconded by William Reece, and unanimously carried as approved.

A motion to adjourn the meeting was made by Dan Castle, seconded by William Reece and unanimously carried as approved.
